Driver's Education Update -- please read this important information!

First Flight High School is implementing a new signup system for Driver's Ed to more efficiently offer this service to the 300 students who are eligible or will become eligible for the classroom portion of driver training this year.

Included with this post are documents that also are available on the FFHS website and in the Counseling Center that outline which students can sign up for classes offered throughout the school year. Please carefully read through this information.

Classes throughout the year will serve students further down the eligibility list, and by the end of the school year, every eligible student at FFHS will have the opportunity to take one of the classes here.

ATTN: FFHS Parents Regarding the Classroom Portion of Driver's Education

North Carolina Driving School is the company who provides the Driver Education for First Flight High School. Students must be an age of 14 ½ to take the course; however, due to the amount of students needing Driver's Education we have gone to a new system for signing up for the classroom portion. Classes are now created using date of birth as the criteria for building them. The first opportunities are given to the older students, then to the younger students. There will be **no waiting list** for the classroom portion of Driver's Education and each class holds 40 students.

The next class available (which is the class starting April 16th) will be open to students whose date of birth falls between May 2000 to **October 16, 2003**. There is a \$65 **non-refundable** fee for the class. You may bring cash or a check made out to FFHS. You will also need to fill out the Restricted Instruction Permit **in Black Ink** and return it with the \$65.00 to Mrs. Mitchell in the Counseling Center at First Flight High School. Attached is the Restricted Instruction Permit form, as well. If you do not have access to a printer, there are copies available.

We are accepting the form (Restricted Instruction Permit) and the fee starting on **Monday, March 26, at 7:45 am**. The class will close when it reaches 40 students or Friday, March 30, at 3:00 pm, whichever happens first.

In the future, notices will be posted on Facebook on the FFHS Official Fan Page and on the FFHS Website indicating when registration for the driver's education class opens and the new date of birth range. We want all students to have the opportunity to take Driver's Education and will do our best to get the students into one of the classes in a timely manner.

NC Driving School is solely responsible for scheduling the driving portion of the course. If you have any questions you may call the Driving School at 1 – 800 – 375 – 6550.
